Play Format: Teams comprised of not less than 3 participants will engage in an Inter-City team table tennis

competition, additional pre-registered participants will be permitted but limited to not more than 5 per team.

The format of play is adopted from the USATT Team Play Score sheet which indicates a team winning a contest, is the result of at least two players from each team playing 2 singles matches and a double match against the corresponding players from another team. (Defined as a contest) The same player may not

compete in consecutive singles matches, within that contest.

Order of play will be 2 singles matches and a doubles match followed by additional single matches until a best 3 out of 5 for that contest has been achieved. Play will stop when the contest has been decided.

The tournament will involve all registered teams competing against each of the other registered teams for one contest each. Winning a contest is determined by the best three out of 5 matches. A match is determined by the first player to win 3 out of 5 games. The games will be played to 11 win by 2. USATT rules will apply. The overall won/loss record and applicable tie breaker criteria (if necessary) will determine the tournament champion. If the number of registered teams exceeds 12 teams at the close of registration (9:45 am) A determination to divide the field of competing teams into equal/practical sets, paired at random by lot, and then the two best won/loss record achieving from each grouping will advance to a final contest to determine

the tournament champion.

Equipment: Only USATT approved equipment will be used. Eight Butterfly Tables, Butterfly Barriers and
